**ELIGIBILITY REQUIREMENTS FOR TENNIS PROGRAM**

1. The program will begin Thursday, September 22.
2. Children residing in the Long Beach City School District and/or attending Long Beach Schools are eligible to enroll in the LIFTALL Tennis Program beginning September 1, 2016.
3. Registration begins for Non-Residents on September 12, 2016.
4. A \$5 late registration fee may be added for anyone registering after October 10, 2016.
5. Child must be in Kindergarten through 5<sup>th</sup> grade as of September 2016.
6. Dates for the Thursday classes are September 22 and 29, October 6, 13, 20 and 27 and November 3 and 10.
