

**CITY OF LONG BEACH  
MINUTES OF THE REGULAR MEETING  
OF THE COMMON COUNCIL  
HELD AUGUST 3, 2021**

A regular meeting of the City Council of the City of Long Beach was held on Tuesday, August 3, 2021.
