1. Resolution Authorizing the City Manager to Purchase a Street Sweeper for the City's Highway Department Through the HGAC Buy National Cooperative.

Legislative Memo: As a member of the HGAC Buy National Cooperative, the City can make purchases of goods and services from competitively awarded vendors which are only available to governmental units. Cooperative purchasing contracts ensure that all public agencies are receiving products and services of the highest quality at the lowest prices. Funding to purchase the street sweeper is provided through the Capital Improvement Plan.

2. Resolution Authorizing the City Manager to Amend the Contract for the Rental of Portable Restroom Trailers for the Ocean Beach Park.

Legislative Memo: After the damage caused by Superstorm Sandy, the City rebuilt five ADA compliant comfort stations. Since the storm the City has been renting additional, portable restrooms for each beach season. This season, one additional restroom was needed for two months. Funding is provided through public assistance grant monies from FEMA.

Resolution Authorizing the City Manager to Purchase a

WHEREAS, the City is a member of the U.S. Communities Government  
Purchasing Alliance and the National Joint Powers Alliance, leading national government  
purchasing cooperatives, affording the City government pricing available throughout the United  
States; and

WHEREAS, it is the City's desire to now join the HGAC Buy National  
Cooperative and the National IPA Cooperative, to enter into agreements with other governmental  
units in the United States, to utilize contracts competitively solicited and awarded as best value  
by other governmental units at no cost to the City, in order to obtain cost savings from numerous  
vendors; and

WHEREAS, through the HGAC Buy National Cooperative, the City can purchase  
a Johnson N.A. Street Sweeper, from Vasso Systems Inc., 159 Cook Street, Brooklyn, New York  
11206, the sole sales and service distributor in Nassau County, at a cost of \$275,095;

NOW, THEREFORE, be it

RESOLVED, by the City Council of the City of Long Beach, New York that the  
City Purchasing Agent be and is hereby authorized to register the City of Long Beach as a  
member in the HGAC Buy National Cooperative and the National IPA Cooperative; and be it  
further

RESOLVED, by the City Council of the City of Long Beach, that the City  
Manager be and he hereby is authorized to purchase a Johnson N.A. Street Sweeper, from Vasso  
Systems Inc., 159 Cook Street, Brooklyn, New York 11206, at a total cost of \$275,095, through  
the HGAC Buy National Cooperative. Funds are available in Account No. H1018.52220  
(Capital-Machinery & Equipment).

Resolution Authorizing the City Manager to Amend the

the Ocean Beach Park.

WHEREAS, pursuant to Resolution No. 31/17, duly adopted on April 4, 2017, the City entered into an agreement with Direct Drainage, 363 N. Dunton Avenue, East Patchogue, New York 11772 2017 for the rental of portable restroom trailers for the Ocean Beach Park for a period of five months, during the beach season; and
