1. Resolution Granting Waiver of Off-Street Parking Requirements for Premises:  
Re: 138 East Park Avenue (street floor), Long Beach, New York.

The application of owner East Park Avenue Associates, LLC, Long Beach, New York for exemption with respect to the requirements for off-street parking at premises 138 East Park Avenue (street floor), Long Beach, New York Long Beach, New York, is granted, only and during the time that such premises shall be used as a nail salon.
