1. Local Law Amending the Charter of the City of Long Beach Re: Assessment; Levy; Collection of Taxes

Summary: This local law adds the following to Charter Sec. 104-d – “**All medical and prescription expenses which are not reimbursed or paid by insurance shall be excluded from the computation of an applicant’s income**”

2. Resolution Authorizing the City Manager to Purchase Information Technology Equipment for the City’s Police Department through New York State Office of General Services.

The City Manager is authorized to purchase desktop computers, monitors, back-up batteries and surge protection units for the City’s Police Department, at a total cost of \$74,793.87, from Dell Marketing LP, Round Rock, Texas through New York State Office of General Services, Information Technology Umbrella Contract #PM20820.

4. Resolution Authorizing the City Manager to Retain an Appraisal Consultant for Real Property Valuation Services

The City Manager is authorized to retain Standard Valuation Services, Mineola, New York for real property valuation consulting services for the Equinor-Empire Offshore Wind Project, at a cost not to exceed \$25,000.00 without further City Council authorization.
