

EXECUTIVE ORDER

Number 11 of 2020

Local Emergency Order No. 11

DONNA M. GAYDEN, City Manager of the City of Long Beach, County of Nassau, State of New York, pursuant to the power vested in her by Section 20 of the Charter of the City of Long Beach and the laws of the State of New York do hereby order and declare as follows:

WHEREAS, Section 24 of the New York State Executive Law authorizes the chief executive officer of a city, pursuant to a declaration of a local state of emergency, to issue orders to preserve the public safety, well-being and health of such city in times of emergency; and

WHEREAS, the City of Long Beach declared a local state of emergency on March 14, 2020; and

WHEREAS, on April 13, 2020, I extended the local state of emergency and issued Local Emergency Order No. 1, closing the boardwalk of the City of Long Beach in accordance with Local Executive Law § 24; and

WHEREAS, Local Emergency Order No. 1 has been extended multiple times in accordance with Executive Law § 24; and

WHEREAS, pursuant to Executive Law § 24, I intend to modify Local Emergency Order No. 1 by opening the boardwalk subject to the following:

- The boardwalk, including its ramps, entrances, access points, and facilities are hereby designated safety zones pursuant to Chapter 15 of the Code of Ordinances.
- The boardwalk will be open daily from dawn to dusk.
- Signage regarding the flow of traffic and the below rules will be posted and have the same force and effect of signage indicated in Chapter 15 of the Code of Ordinances.
- All individuals on the boardwalk must wear a mask or facial covering when not maintaining the appropriate social distance of six (6) feet.
- Individuals may not gather or remain idle while on the boardwalk or its ramps, except individuals may remain idle when waiting for the restroom, entrance to the Ocean Beach Park (if applicable), or for grab and go at a concession so long as they abide by the relevant signage and direction of City personnel.
- The southern side of the boardwalk shall be designated for east bound traffic, the northern side of the boardwalk shall be designated for west bound traffic, and the center lane shall be designated for bicycle traffic.

- Bicyclists are prohibited from utilizing the boardwalk except from sunrise to 10 a.m. daily. When on the boardwalk, cyclists must utilize the center lane of the boardwalk for cycling.
- Boardwalk bathrooms will be open from dawn to dusk. Admittance to any such bathroom is limited to two (2) individuals at a time. Individuals waiting for the bathroom must form a queue and maintain social distancing until it is their turn.
- Concessionaires on the boardwalk will be allowed to serve the public in accordance with the Governor's Executive Orders, but must proactively ensure that their patrons are maintaining proper social distancing and taking the proper precautions. Concessionaires are prohibited from offering seating or sit-down service to patrons.

NOW, THEREFORE be it

ORDERED, that Local Emergency Order No. 1 is hereby modified as set forth above until further notice; and

ORDERED, that this emergency order shall be effective May 26, 2020 and shall remain in effect for five (5) days unless extended, rescinded or modified in accordance with Executive Law § 24 (2).
