1. Resolution Authorizing the Acting City Manager to Purchase Two Gillig Low Floor Diesel Buses

The Acting City Manager is authorized to purchase two (2) eco-friendly fuel efficient Gillig 29.95ft. Low Floor Diesel Buses with specified options at a cost of \$552,952.00 each, for a total cost of \$1,105,904.00 from Gillig Corporation, Livermore, California.

2. Resolution Authorizing the Acting City Manager to Purchase Miscellaneous General Hardware Items on an “As Needed” Basis

The Acting City Manager is authorized to purchase miscellaneous general hardware items on an “as needed” basis from Centre Millwork & Supply Co., Inc., Long Beach, New York, Whitbread’s & Sons Lumber Co. of Long Beach, Inc., Long Beach, New York and Bellmore Home Center, Inc. d/b/a Costello’s Ace Hardware, Island Park, New York for a period of one year, with the option for two additional one year renewals.

The Acting City Manager is authorized to purchase from the following lowest responsible bidders in accordance with specifications on file in the Office of the City Purchasing Agent, on an “as needed” basis as follows, for a period of one (1) year: Item 1: Aluminum Sulfate Liquid – Thatcher Company of New York, Inc., Salt Lake City, Utah, at a bid price of \$1.059 per gallon; and Item 2: Hydrated Lime Bulk – Carmeuse Lime, Inc., Pittsburgh, PA at a bid price of \$210.00 per ton.
