Resolution Authoring Payments for the Title Closing Report and
the Required Environmental Assessment/SEQRA Administration

WHEREAS, pursuant to Resolution No. 102/18, duly adopted by the City Council
on December 18, 2018, the City of Long Beach and the Town of Hempstead entered into a
Memorandum of Understanding for the purchase of underwater land required to complete the
Critical Infrastructure Flood Protection Project at a price of \$55,250; and

WHEREAS, Abstracts Incorporated, 100 Garden City Plaza, Suite 201, Garden
City, New York 11530 is providing the title closing services at a cost of \$1,732.00; and

WHEREAS, Nelson Pope & Voorhis, LLC, 572 Walt Whitman Road, Melville,
New York 11747 prepared the Environmental Assessment Form Parts I/II and provided the
SEQRA administration at a cost of \$1,800.00;

NOW, THEREFORE, be it

RESOLVED, by the City Council of the City of Long Beach, New York that the
Acting City Manager is hereby authorized to pay Abstracts Incorporated, 100 Garden City Plaza,
Suite 201, Garden City, New York 11530 the sum of \$1,732.00 for title closing fees for the
above underwater land purchase; and be it further

RESOLVED, by the City Council of the City of Long Beach, New York that the
Acting City Manager is hereby authorized to pay Nelson Pope & Voorhis, LLC, 572 Walt
Whitman Road, Melville, New York 11747 the sum of \$1,800.00 for the preparation and
providing of the EAF Parts I/II and the SEQRA administration for the above underwater land
