EAS NY 11561, hereinafter called the BIDDER/CONTRACTOR, is for all Product(s)/Services required for the CLB037-2022 Lifeguard Stands (re-bid) described hereinafter called the Product/Service.

**NOW, THEREFORE**, THE OWNER and CONTRACTOR for the consideration hereinafter set forth, agree as follows:

THE CONTRACTOR AGREES to supply and/or perform and complete in a workmanlike manner all Products, Services and/or Public Work required herein, in strict compliance with the Contract Documents, which are hereby made a part of this Agreement.


CONTRACTOR AGREES to provide a repair/replacement warranty for all defective and/or damage chairs or portions thereof for a period of 2 years following delivery of the products which are the subject of this agreement.

Work under this Agreement shall commence upon written Notice to Proceed and shall terminated expire upon payment of the amount(s) as heretofore stated in the bid/proposal, following delivery of the Product, completion of the Services, and/or performance of the work as heretofore stated in this Proposal satisfactory to the Town within the Contract time as heretofore stated in the Proposal.

THE OWNER AGREES to pay, and the Contractor agrees to accept, in full payment for the performance of this Contract, the Contract amount as heretofore stated in this Proposal, as finally adjusted, if necessary, in accordance with the provisions of the Contract Documents.



Resolution Authorizing the City Manager to Purchase  
Lifeguard Stands from the Lowest Responsible Bidder.

WHEREAS, after due advertising therefore, two (2) bids were received in the  
Office of the City Purchasing Agent on Thursday, March 10, 2022 at 11:00 a.m. for the purchase  
of twenty-four (24) new lifeguard stands for the Ocean Beach Park; and

WHEREAS, Taj Damico d/b/a Fine Line Design Studio, 46 Mohawk Avenue,  
East Atlantic Beach, New York 11561 was the lowest responsible bidder at a cost of \$2,500 per  
stand, at a total cost of \$60,000; and


WHEREAS, pursuant to Resolution No. 68/21, a charitable donation in the  
amount of \$300,000 was given to the City of Long Beach by John A. Carbona, to be used for  
purchases for the Lifeguard Department and for future Lifeguard Departmental operations; and


WHEREAS, in accordance with Mr. Carbona's donative intent, the City shall use  
funds from this donation to pay for the purchase of the twenty-four (24) new lifeguard stands for  
the Ocean Beach Park;


NOW, THEREFORE, be it


RESOLVED, by the City Council of the City of Long Beach, New York that the
