PLEASE NOTE:

- **Initial Application Fee:** \$70.00 for all members of the Nassau County Tri-Town Plumber’s Agreement with business **OUTSIDE** of Nassau County. No fee for members with business in Nassau County (only the \$400.00 Mercantile License fee). Also a copy of Certificate of Competency must be submitted with initial application.
- **Renewal Fee:** Renewal applications received before expiration date (May 31 of second year of license) are \$400.00 (plus vehicle fees, if applicable). Applications received after expiration date are subject to an additional \$30.00 late fee.
- Applicant must furnish Worker’s Compensation & Disability Benefits Law compliance certificate (C-105.2 or U-26.3 form). If working alone, a Certificate of Attestation of Exemption (Form CE-200) and Compliance with the Disability Benefits Law. The City of Long Beach is to be listed as the “Certificate Holder”.
- Certificate of Insurance naming the City of Long Beach as Certificate Holder with the following coverage:

- Include copy of current Master Plumber’s License **and** Certificate of Competency from a member of the Nassau County Tri-Town Agreement.
- If applying on behalf of a company, **the licensed plumber must own 51% of the company.** Please include proof of ownership.
