Resolution Affirming the Declaration of a State of Emergency
Within the City of Long Beach.

WHEREAS, on March 14, 2020 the City Manager of the City of Long Beach pursuant to the power vested in her by Section 20 of the Charter of the City of Long Beach, declared a State of Emergency within the City of Long Beach; and

WHEREAS, on March 7, 2020, Governor Cuomo issued Executive Order Number 202 declaring a State disaster emergency for the entire State of New York; and

WHEREAS, on March 11, 2020, the World Health Organization declared the novel Coronavirus to be a pandemic; and

WHEREAS, Nassau County Executive Curran declared a State of Emergency for the County of Nassau effective at 11:00 a.m. on March 13, 2020; and

WHEREAS, a Proclamation issued by President Trump on March 13, 2020, proclaims that the COVID-19 outbreak in the United States constitutes a national emergency, beginning March 1, 2020; and


WHEREAS, the Nassau County Commissioner of Health has issued a Declaration of Imminent Public Health Threat from COVID-19; and

WHEREAS, on March 16, 2020, Governor Cuomo issued Executive Order 202.3, issuing directives and suspensions and modifications of State and local laws, necessary to cope with the disaster emergency, which the City of Long Beach and all local government and political subdivisions must comply;

NOW, THEREFORE, be it

RESOLVED, that the City Council of the City of Long Beach, New York hereby affirms and declares that a State of Emergency exists in the City of Long Beach effective at 6:00 p.m. on March 14, 2020.

Declaration of a Local State of Emergency

DONNA M. GAYDEN, City Manager of the City of Long Beach, County of Nassau, State of New York, pursuant to the power vested in her by Section 20 of the Charter of the City of Long Beach and the laws of the State of New York, including Section 24 of the New York State Executive Law to preserve the public safety and render all required and available assistance vital to the security, well-being and health of the citizens of Long Beach, hereby exercises that authority and declares as follows:

WHEREAS, on March 7, 2020, Governor Cuomo issued Executive Order Number 202 declaring a State disaster emergency for the entire State of New York; and

WHEREAS, on March 11, 2020, the World Health Organization declared the novel Coronavirus to be a pandemic; and

WHEREAS, Nassau County Executive Curran declared a State of Emergency for the County of Nassau effective at 11:00 a.m. on March 13, 2020; and

WHEREAS, a Proclamation issued by President Trump on March 13, 2020, proclaims that the COVID-19 outbreak in the United States constitutes a national emergency, beginning March 1, 2020; and


WHEREAS, the Nassau County Commissioner of Health has issued a Declaration of Imminent Public Health Threat from COVID-19; and

WHEREAS, this situation threatens the public health and safety of the citizens of Long Beach;

IT IS HEREBY ORDERED that a State of Emergency is declared and exists in the City of Long Beach effective at 6:00p.m. on March 14, 2020; and

IT IS FURTHER ORDERED, that this State of Emergency will remain in effect for thirty (30) days, or until rescinded by a subsequent order, whichever occurs first.
